- 3. New business –**
 - a. Communication Minor Map
 - i. Change spelling to “Six” (6)
 - ii. Concern with the fact that there is not a current plan to regulate number of majors
 - iii. Communication department discussed how it compares to other departments across campus and having 10 courses for major and 5 for minor wanted to increase
 - iv. A minor increase to 6 is “doable” with the current faculty, a major increase may be dependent on position requests
 - v. Adding another 300-level course to the concentrations is another step
 - vi. Motion to approve changes to the Communication Minor Map with listed changes (spelling, missing lines)
 - vii. DECISION: APPROVED (8-0-0)
 - b. Midterm Grades
 - i. EC not in favor, adding the word “estimated” helped assuage their concerns
 - ii. New students need this perhaps more than upperclassmen

- iii. Academic warning system may be affected or even bypassed by this new regulation
 - iv. Motion to table until the spring
 - c. Holt gen ed
 - i. ECMP is embedded, why not assessed to match CLA?
 - ii. SACS will have a problem with discrepancies
 - iii. Motion to approve Holt Gen Ed framework with proposed addition of “If the proposed changes to Holt general education are approved, faculty directors and Academic Affairs will work in the spring to develop an assessment plan for these learning outcomes (to be grounded in the LEAP VALUE rubrics). This process will take the assessment model for rFLA as a starting point and establish parallel protocols for the Holt program.”
