- a. Studio Art Holt Minor
  - i. Been teaching cross-listed courses for the last 20 years
  - ii. Due to the way the department is currently treating these courses, the new minor would not need additional staffing or courses
  - iii. Last 4 years, about 1/3 of Holt students take minor
  - iv. Top 3 - Communication, International Affairs, Business
  - v. Bottom 3 - African-American Studies, Jewish Studies, Dance
  - vi. Opens up opportunity for students to get Art gen ed requirement
  - vii. Humanities major may be most attractive to Studio Art minors allowing some cross over
  - viii. Motion to approve Studio Art minor in Holt School
  - ix. DECISION: APPROVED (10-0-0)
- b. Creative Writing Minor Map Revision
  - i. Motion to approve revision to Creative Writing Minor map
  - ii. DECISION: APPROVED (9-0-0)
- c. Department of Modern Language name change
