 - i. Presentation at Summit
 - c. Exclusion Criteria
 - i. Students asking for more than the max amount – are the instructions clear about leaving the budget
 - d. Trip Waivers
 - i. Apply to summer programs as well
 - ii. Students don't receive trip waivers, but advisors who create them do
 - b. Summit 2017 – coordinating with students to present during the lunch hour to present for Friday

 - a. Sodexo presented a packaged program, similar to Blue Apron
 - b. Greek houses and Sutton – this could be a great hit

 - a. Parking – tabled for the next meeting

 - ii. When we have visitors – why are the visitors not asked to park in the garage?
- 7. Fraternity “Pause”
 - a. LipSync will be pushed back until April 9th, 2017 – it would be a bigger statement would be to cancel LipSync
 - iii. Was not canceled because it is an SGA event and it should not be imposed upon the entire campus
 - b. Fraternities will be able to conduct business after March 31st
 - c. Important that the school has made a stance, there are many issues that have not been caught by the college; students are supportive of the stance
 - d. Perceived as possibly blanketed – guilty by association but it should be going through the summit instead of Greek Week
 - e. Some organizations have frequent and continuous issues that are in the organization and it has become cultural with these organizations
 - f. Different fraternities are making pledges to not participate in certain behaviors
