**Fox Funds Eligibility**

**Whereas:** There are no formal requirements for the distribution of Fox Funds.

**Be it Hereby Resolved, The Student Government Association of Rollins College will:**

(1) Make the following changes to the Constitution

1. Under Article VII, Section 3, add the following subsection

B. Fox Funds.

I. Eligibility.

1. All registered student organizations on campus are eligible for funding, which includes A&S, CPS, Holt, and Crummer schools. If you want to plan an event that would be open to all of campus but you are not a registered student organization then please contact [getinvolved@rollins.edu](mailto:getinvolved@rollins.edu).

2. Before submitting funding request, student organization must explore outlets of outside funding and resources including, but not limited to dues, departmental funding, and Rollins departmental resources.

3. If an organization has already allocated a budget for an initiative at the beginning of the academic year, they will not be eligible for funding. In addition, if they have a parent organization providing funds they are also ineligible.

4. Fox Funds will only fund events that are open to the entire campus. We cannot provide assistance for an event that will only benefit the organization directly. A closed program is one that is not open to the student community at large, but only to members or invitees of the organization. If an event is held off-campus the organization must provide some form of open transportation to the event in order for the event to be considered open.

5. If you are requesting more than \$200, you must present your request for funding to the committee in person.

6. Requests are discussed in order they are received. Your organization must submit requests two weeks before the date of initiative to be considered for funding at our next meeting. To be considered for reimbursement, your organization must present your proposal and receipt no later than 2 weeks after the event.

7. Requests over \$10,000 must be presented 30 days before date of initiative/event.

8. A maximum of \$100 can be requested for advertising. It is encouraged the student organization present a draft of their physical advertising. If advertising funding is approved it is mandatory for the student organization to include the Fox Funds or Student Government Association logo on physical advertising and/or social media.

9. T-Shirt funding is capped at \$5 per shirt.

10. Approved funding requests must include advertising or other promotional materials with the phrase, "Presented by Fox Funds" on it. Organization that fail to comply will only be eligible to receive a maximum of 80% of all future requests.
