Senate Bill: Authorization of Sodexo Ad-Hoc Committee and the Campus Projects Ad-Hoc Committee

DATE: October 23, 2019

Whereas: The Senate of Rollins SGA is entrusted with the authority to create ad-hoc committees as it deems necessary

Whereas: It has been requested for the creation of a Sodexo Ad-Hoc Committee to represent Rollins Dining Services

Whereas: It has been requested for the creation of a Campus Projects Committee

Be it Hereby Resolved, The Student Government Association of Rollins College will:

1. The authorization of a Sodexo Ad-Hoc Committee to serve as the direct liaisons and ambassadors for Rollins Dining Services
 - a. This committee shall be comprised of no less than three and no more than six representatives from Rollins SGA Senate
 - b. This committee shall have the power to appoint its own chairperson
 - c. The Attorney General shall serve on this committee as a non-voting ex-officio member to represent the Executive Council
 - d. This committee shall be authorized to represent the Rollins SGA Senate until the close of the Spring 2020 Academic Term
 - e. This committee shall from time to time report back to the entirety of the Rollins SGA on the actions and opinions of the committee
2. The authorization of a Campus Projects Committee Ad-Hoc Committee to serve as a focus group with Dr. Meghan Hart Weyant, Micki Meyer, and other administrators to get direct feedback and opinions on upcoming projects such as the Lakeside Residences
 - a. This committee shall be comprised of no less than three and no more than six representatives from Rollins SGA Senate
 - b. This committee shall have the power to appoint its own chairperson
 - c. The Attorney General shall serve on this committee as a non-voting ex-officio member to represent the Executive Council
 - d. This committee shall be authorized to represent the Rollins SGA Senate until the close of the Spring 2020 Academic Term
 - e. This committee shall from time to time report back to the entirety of the Rollins SGA on the actions and opinions of the committee
